

**DECLARATION UNDER RIGHT TO INFORMATION (RTI)**


**STATUTORY DECLARATION ON RTI ACT**

Section 4(1)(b) of RTI Act 2005 covers the statutory declaration of Shikshanmaharshi Dr. Bapuji Salunkhe College, Miraj on website. It covers all the rules and regulations which are made by Govt. of Maharashtra.

Our College is a "College of Co-education". The Collge is affiliated to Shivaji University, Kolhapur, Maharashtra and it is governed by Shri Swami Vivekanand Shikshan Sanstha, Kolhapur. The Sanstha is registered under Society Act of Govt. of Maharashtra. The Sanstha has a Governing Body which is composed and approved by the authority appointed by Govt. of Maharashtra. The Sanstha runs as per rules and regulations made by the Govt. from time to time.

The College comes under "Grant in Aid" category therefore financial transactions are audited by the government. The College has different Bodies to maintain all types of disciplines in the campus.

All the cells or committees of the college are under Statutory Bodies and comes under section 4(1)(b) of RTI Act 2005.
